### **PRIMARY ELECTION SYSTEM – Section 14.5 Types of Elections** (Constitution & General Laws)

- #1. When there are only two (2) Candidates for an Office, the one who receives the majority of the votes cast is elected.
- #2. If there are three (3) or more Candidates for the same Office, a Run-Off Election will be necessary UNLESS one (1) Candidate receives a MAJORITY OF VOTES CAST. Should no one receive a MAJORITY OF VOTES CAST, the two (2) Candidates with the highest number of votes shall contest, in a Run-Off Election.

## ELECTION OF OFFICERS OF LOCAL 1056

The date for Election of CASEY STENGEL DEPOT Assistant Shop Steward for ATU Local 1056 will be Thursday, February 12, 2026.

In order to comply with **Section 14.2 Eligibility for L.U. Office**, as specified in Constitution and General Laws, & ATU 1056 By-Laws, the following **Election Notice** is concerning Local 1056 Election of CASEY STENGEL DEPOT Assistant Shop Steward on Thursday, February 12, 2026.

### **A. GENERAL QUALIFICATIONS REQUIRED TO BE ELECTED FOR LOCAL OFFICES**

(As per Section 14.2 of the Constitution & General Laws).

1. Must be an Active Member in continuous good standing of ATU Local 1056 for two (2) years.
2. Must have attended six (6) Regular Meetings each year during the twenty-four (24) months. (Including Nomination Meeting)
3. **Note:** In the event that an Office is open and there are no members of ATU Local 1056 eligible to run for that Office, due to the fact no one has the required meetings (see A.2), in this instance only nominations for that Office will be open to all Members otherwise ineligible.
4. Any member, who wants to be nominated for Elected Office but is unable to attend the nomination meeting, may indicate one's acceptance of his/her nomination in writing, provided it is received prior to the opening of either of the nomination meetings referenced above.

### **THE FOLLOWING OFFICE POSITIONS WILL BE OPEN FOR ELECTIONS:**

#### **#1. ASSISTANT SHOP STEWARD/TRANSPORTATION – Casey Stengel Depot**

#### **NOTE:**

- a. **All Shop Stewards and Assistant Shop Stewards – Transportation and Maintenance**, must work in their respective Depot and Departments to be elected.
- b. **Ballots for All Shop Stewards and Assistant Shop Stewards – Transportation and Maintenance**, may only be filled by Members within their respective Depot and Department.

**This election is to fill the vacant Casey Stengel Depot Assistant shop steward position in Transportation. ONLY members in good standing in Casey Stengel Transportation can vote for this position.**
